Notes from the 2020-2021 SCBA Leadership Team

Notes from SCBA President

Dear Fellow SCBA Members and Friends,

Usually the end of a year is a time for reflection. The past year has been anything but usual. March became a time of reflection as it was March 2020 when CDC declared Covid-19 a pandemic and our lives abruptly and drastically changed. Directly relevant to the SCBA, we had to make multiple changes regarding our biennial conference originally scheduled for the summer of 2021. Our initial plan was to have the meeting in Changchun, China. When the pandemic hit, international travel became a concern and we decided to take the meeting back to US and hold it in Boston in July 2021, feeling very confident that the pandemic would be long over. Indeed, we have finalized the venue and assembled all the

committees. Little did we know that the situation would become so dire and, by the end of 2020, it became apparent that a summer 2021 gathering would be too risky, and we made the painful but sensible decision to postpone it to July 2022. Finally, there is good reason to believe that we are at the end of this very long and dark tunnel. I hope many of you have been vaccinated and are able to enjoy the blooming spring flowers free of anxiety.

In the past three months, the SCBA participated in two initiatives impacting the Chinese American scientists. One is joining the call for a congressional hearing on racial profiling of Asian American and Chinese Scientists; the other is the involvement of the newly formed Chinese Scholar Forum. A letter requesting the hearing was initiated by Maryland State Senator Susan Lee and Chair of the Board of the Institute of Human Virology at the University of Maryland Terry Lierman, and was delivered to Representative Jamie Raskin (MD-8), Chair of the Subcommittee on Civil Rights and Civil Liberties, in early February. The purpose is to urge Congress to take steps to end racial profiling and unfair investigations into researchers and scholars of Chinese descent. Mr. Frank Wu, President of Queens College, City University of New York, has agreed to testify at the hearing representing the SCBA and a number of other organizations. We hope that such a hearing will take place in the near future. The Chinese American Scholar Forum was established following the criminal accusation of Gang Chen, a prominent MIT professor. The short term goal is to organize webinars and to engage dialogs among various entities. So far the Forum has hosted two

webinars: One presented by the well-known lawyer Brian Sun and the other a dialog with the Department of Justice on China Initiative. Both were well-attended. I hope you had a chance to tune in and I encourage you to attend future events. I should note that SCBA hosted a related webinar in April 2020, Which was moderated by Frank Wu and presented by well-known legal minds Paul Thaler and Shanlon Wu and was well attended by our members.

I will end where I started. With the Covid-19 under control (hopefully) and herd immunity within reach, the SCBA leadership has started the preparation for our biennial (triannual in this case) conference. Stay tuned for more information in the next Newsletter.


Notes from SCBA Secretary



Notes from Editor-in-Chief of Cell & Bioscience

Dear SCBA Members,

Cell & Bioscience is the SCBA society journal. It has grown significantly since its inception in 2009. Under the leadership of former Editor-in-Chief, Yun-Bo Shi of NIH, it has achieved tremendous success as an elite multi-discipline journal with a recent two-year impact factor of 5.026. Early estimate suggests that the impact factor will likely increase further in 2020, when it is announced in June of this year. For 2020, we received a total of 910 submissions to the journal, which is significantly higher than prior years. This number is anticipated to increase even further in 2021. The success suggests that Cell & Bioscience has become a valuable journal for investigators to report their scientific findings, and it also posts a challenge(s) for the Editorial Board to evaluate expeditiously the merits of these submissions. This demand exerts a heavy load(s) on the Editors, who are working on a voluntary basis as experts in their respective fields. In order to identify solutions for these challenges, An Editorial Board meeting was held on February 17, 2021 via Zoom with majority of the Editors participating remotely. The discussion is briefly summarized in the following.

The Publisher, Ms. Rebecca Pearce, presented a comprehensive overview of the journal with information on the numbers of submissions, acceptance, published articles and rates of acceptance, rejection and withdrawal from 2015-2020. Importantly, the recent acceptance rates for the past two years were about 20%, suggesting that only high-quality manuscripts are likely to be accepted for the journal.

With the significant increases in both submissions and impact factor in recent years, a reorganization of the Editorial Board is essential to address these challenges. The Editor-in-Chief led a general discussion, which


resulted in the established of a system for the Editorial Board of Cell & Bioscience. All Editors, including the Editor-in-Chief, Associate Editor-in-Chief, Editors, and members of the Editorial Board will now serve on *renewable* terms, ranging from 3 to 5 years, thereby providing opportunity for review of the mutual commitments of the Editors and Editorial Board members with the journal in regular intervals. An Editorial Administrative Committee (Editorial Committee), consisting of the Editor-in-Chief (Chair) and the Associate Editor-in-Chiefs, is being established. As a group, the Editorial Committee will administer and make decisions on the daily business of the journal.

The classifications of the specific fields of journal are being refined and now consist of 8 general classifications with the Editor-in-Chief and the three Associate Editor-in-Chiefs serving as Section Editors of two classifications of their respective expertise. A streamline review process is being established. To lessen the loads of the current Editors and to increase the available expertise, we are actively recruiting qualified Editors/Board members/reviewers in scientific areas currently lacking in the Editorial Board. We hope that this reorganization will provide means to efficiently evaluate the merits of the large volume of submissions and the opportunity to select the high-quality manuscripts for publication in Cell & Bioscience.

Other matters, such as the annual selection of Ming Jeang Awards and Thematic Series and scientific integrity of submissions, were discussed. The Editorial Board meeting was adjourned after close to 2-hour fruitful discussion.

As members of the Society, there are numerous ways you can participate and help to foster the growth of our journal. You can submit research and/or review articles of your field(s) to the journal for publication. Your submissions will greatly improve the scientific

standing on the quality of publications in Cell & Bioscience. You can also serve and/or recommend qualified colleagues or associates to serve on the Editorial Board. In particular, serving as reviewers could promote the scientific development of junior colleagues under your supervision. As the new classification system is implemented, please logon to the journal portal and update your profile and provide a few personal keywords of your specialty on our database. 2021 SCBA Election

Call for Nominations of Candidates for the Election of SCBA Officers

In accordance with the SCBA Bylaw, the Nomination Committee is calling for the nominations of candidates for the 2021 SCBA Election of the Chief Operating Officers (COOs) and membership of Council and Nomination and Membership Committees.

Regulation and Submission Process of Nominations

- 1) The nominated candidates must be a lifetime member of SCBA at the time be nominated in order to be eligible to stand for election.
- 2) The candidates can be nominated by a SCBA member or self-nominated.
- 3) The deadline of nomination is July 1, 2021.
- 4) Nomination package includes
 - The Nomination form (see the last page).
 - CV of the nominee
- 5) The nomination should be sent to:
 - Jun Lu, Yale University (jun.lu@yale.edu) the Co-Chair of the Nomination Committee
 - Copy to Lee Zou (lzou1@mg.harvard.edu), the Secretary of SCBA.

Selection Process

The Nomination Committee will

- 1) review the nominations, and convene a meeting following the nomination deadline
- 2) propose an official ballot and obtain a brief curriculum vita and a description of service to the Society from each of the nominees for each position, based on the eligibility and willingness to serve of the nominees, the Nominating Committee
- 3) tabulate a list of candidates for the consideration and final approval by the SCBA Council.

The Executive Director shall forward the official ballot to all Active Members on or before August 15, 2021 for a vote by electronic means.

The finalists of the nominated candidates will also be posted on the SCBA website: <http://www.scbasociety.org/>.

Voting Process

The members will select their choices of the respective positions by filling out their election ballots and submit the ballots via emails to: Xi He (Xi.He@childrens.harvard.edu), the Co-Executive Director and Yong Xu (yongx@bcm.edu), the Treasurer of SCBA by September 15, 2021 deadline.

The ballots shall be opened by the Executive Director and the Treasurer in the presence of at least one other Council member or person designated in writing by a Council member.

The results of the election shall be tabulated, rectified, and submitted to the Council for final approval. The elected individuals will be informed of the results, and the election results will be posted on the official website of the Society and announced in the September 2021 issue of SCBA Newsletter.

Available Positions

The positions, and their terms and duties, as described in the SCBA Bylaws, are listed below. The Nomination Committee urges all the SCBA members to nominate the best suitable candidates who represent the interests of the SCBA members and lead the Society moving forward in the future.

CHIEF EXECUTIVE OFFICERS (number): term of service

1. **President** (1): January 1, 2024 – December 31, 2025

The President shall be the Chief Executive Officer of the Society and shall preside at all meetings of the Council. Subject to the control of the Council, the President shall have general executive charge, management, and control of the properties, business, and operations of the Society with all such powers as may be reasonably incident to such responsibilities; shall have the authority to agree upon and execute all leases, contracts, evidences of indebtedness, and other obligations in the name of the Society subject to the approval of the Council; and shall have such other powers and duties as may be designated in these Bylaws and as may be assigned to such officer from time to time by the Council. The President shall take a leadership role in the organization and implementation of a Biannual International Symposium during his/her tenure.

2. **Secretary** (1): January 1, 2024 – December 31, 2025

The Secretary shall keep the minutes of all meetings of the Council in books provided for that purpose; shall attend to the giving and serving of all notices; shall organize the Council Meeting and all Council meetings; in furtherance of the Society's purposes and subject to the limitations contained in the Articles of Incorporation, may sign with the President in the name and on behalf of the Society and/or attest the signatures thereto, all contracts, conveyances, franchises, bonds, deeds, assignments, mortgages, notes, and other instruments of the Society; shall have charge of the Society's books; records, documents, and instruments, except the books of account and financial records and securities of which the Treasurer shall have custody and charge, and such other books and papers as the Council may direct, all of which shall be open at reasonable times to the inspection of any Member upon application at the Society's office during business hours and approved by a majority vote of the Council; and shall in general perform all duties incident to the office of Secretary subject to the control of the Council.

3. **Treasurer** (1): January 1, 2024 – December 31, 2025

The Treasurer shall have custody of all of the Society's funds and securities that come into such officer's hands. When necessary or proper, the Treasurer may endorse or cause to be endorsed, in the name and on behalf of the Society, checks, notes, and other obligations for collection and shall deposit or cause to be deposited the same to the credit of the Society in such bank or banks, or financial depositories and in such manner as shall be designated and prescribed by the Council; may sign or cause to be signed all receipts and vouchers for payments made to the Society either alone or jointly with such other officer as may be designated by the Council; whenever required by the Council, shall render or cause to be rendered a statement of the cash account; shall enter or cause to be entered regularly in the Society's books to be kept by such officer for that purpose full and accurate accounts of all money received and paid out on account of the Society; shall perform all acts incident to the position of Treasurer subject to the control of the Council; and shall, if required by the Council, give such bond for the faithful discharge of such officer's duties in such form as the Council may require.

COUNCIL AND COMMITTEES (number): term of service

4. Council Member (2): January 1, 2022 – December 31, 2025

Two Councilors shall be elected every other year by mail or electronic ballot to serve for a period of four years and shall assume office on the first day of January of the following year. Councilors shall (i) attend each meeting of the Council, (ii) advise the President with respect to financial matters, the Society's publications, national and international issues that may affect the future of the Society and other matters relating to the Society, the local chapters and the membership, and (iii) serve as liaisons to other scientific and professional societies. Councilors shall not be eligible for immediate reelection, unless such election is recommended by a vote of three-fourths (3/4) or more of the other members of the Council or a majority vote of the Active Members.

5. Nomination Committee (6): January 1, 2022 – December 31, 2023

A Chair and five (5) members of the Society, who hold no other elective office, shall be elected to be the Nomination Committee by mail or electronic ballot on the second year of the new administration of the SCBA.

The six candidates who receive the highest number of votes shall be declared elected; the one receiving the most votes shall serve as the Chairperson. The Nominating Committee members shall assume their responsibility on January 1 immediately following the year of their election for a two-year term. It shall be the responsibility of the Nominating Committee to identify and nominate potential candidates for elected offices of the Society in the election process, starting at the end of the first year of the new administration, with a schedule to be completed before May 15 of the second year, according to the specifications defined by the SCBA Bylaws.

6. Membership Committee (6). January 1, 2022 – December 31, 2023.

A Chair and five (5) members of the Society, who hold no other elective office, shall be elected to be the Membership Committee by mail or electronic ballot on the second year of the new administration of the SCBA. The six candidates who receive the highest number of votes shall be declared elected; the one receiving the most votes shall serve as the Chairperson. The Membership Committee members shall assume their responsibility on January 1 immediately following the year of their election for a two-year term. The Membership Committee shall organize national and local membership drive activities, review and approve membership applications, review and present the record of Members with problems, as defined by these Bylaws, for possible Council action or expulsion, and work closely with the Executive Director in updating membership profiles and publishing the membership directory. The Membership Committee shall also act as a liaison to the local chapters and international membership nominees to serve as officers and representatives of the Society. The Membership Committee shall also identify and recruit individuals with special scientific and technical expertise by nominating them for membership in the Society.


